ORGANIZATION FOR COMPUTATIONAL NEUROSCIENCE FINANCIAL REPORT, 2005

The first conference for Computational Neurosceince (CNS*) held under the auspices of the Steering Committee and Board of Directors of the Organization for Computational Neurosciences was held in Chicago in 2002. This financial report covers the period between 2002 and the present, providing a brief financial history of the organization.

The Organization for Computational Neurosceinces was formally incorporated in the State of California on February 11, 2004. The organization is incorporated under section 501(c)(3) of the Internal Revenue code and is exempt from national taxation. The organization is further exempt from state taxes in the state of California. Because the Organization is incorporated in California, it must maintain an agent of record in that state. Dr. Frances Chance has agreed to act as agent of record for the Organization, and is so listed on the California Statement of Information, which is filed each year.

It is required that the Organization file both state and national taxes each year, confirming its status as a non-profit corporation. The Organization has engaged the firm of Moss-Adams LLP of San Francisco, CA as its tax accountant and all applicable forms were filed this year. No retainer fee is charged.

The Organization changed its bank account from Wells Fargo Bank in Oakland, CA to Bank of America in St. Louis Missouri this year. Bank accounts are managed by L.J. Larson-Prior, treasurer of the Organization. This account provides the general operating fund for the Organization for Computational Neurosciences.
